Political Action Committee of the Iowa Hospital Association

Year in Review

- ★ IHA PAC contributions totaled \$100,858 in 2019 from more than 400 individual contributions representing nearly 80 hospitals.
- ★ Twenty-five hospitals had campaigns meeting or exceeding their hospital's goal.
- ★ Club contributors heard insight and perspectives on the 2020 presidential campaign from David Wasserman, House editor for The Cook Political Report, at the IHA PAC Luncheon.
- ★ The AHAPAC received \$27,900 from Iowa.

IHA PAC Leaders

- ★ Urban Hospital: Methodist Jennie Edmundson raised \$4,900.
- ★ Rural-Referral Hospital: Ottumwa Regional Health Center raised \$2,375.
- ★ Rural Hospital: Spencer Hospital raised \$1,885.
- ★ Critical Access Hospital: Orange City Area Health System raised \$2,325.
- ★ IHA Districts: District A hospitals led the way with combined contributions of \$26,171.
- ★ IHA Staff raised \$16,764 in contributions.
