The IHA PAC is the political action committee (PAC) of the Iowa Hospital Association (IHA). The committee was started in 1990 to promote and facilitate voluntary contributions from IHA members to support candidates for elective office. The IHA PAC is a state PAC. Monies raised through the IHA PAC are used to support elected officials and state candidates who listen to the perspectives of Iowa hospitals and champion IHA's public policy priorities concerning hospitals and the delivery of high-quality health care. The IHA PAC is also a collecting agent for the American Hospital Association (AHA) federal PAC that supports the election of candidates for federal offices. The IHA PAC is nonpartisan and supports members, elected officials and candidates despite party affiliation.

The PAC enables IHA to fully engage on public policy issues to protect the interests of lowa hospitals and health systems and create critical relationships with legislative leaders.

The IHA PAC Committee sets and approves the annual statewide PAC goal and individual hospital goals. Committee members provide input and feedback to help raise funds from members and, in consultation with the IHA legislative team, the committee also approves PAC disbursements.

The IHA PAC Committee is composed of IHA member hospital and health system CEOs. IHA's five geographic districts are represented by their respective residing district chairs. Four at-large committee members are appointed by the Executive Committee, which is comprised of the immediate past IHA board chair who chairs the PAC Committee, the vice chair of the IHA board, and the IHA president and CEO. The current IHA board chair is an ex-officio member of the committee. Committee members serve one-year terms and meet by conference call throughout the year.




