A message from the IHA PAC, the Iowa Hospital Association's political action committee for advocacy

The 2024 election cycle is already well underway. More than ever, it's critical that hospitals and health systems stand together and present a unified voice to lawmakers in Iowa and Washington, D.C.

We continue to face some of the greatest threats to accessing care for patients and communities: workforce shortages, broken supply chains, and inflation that is increasing the cost of care.

The decisions made by Congress and Iowa lawmakers in the coming years will directly impact hospitals and the patients you serve; you have real skin in this game and that is why helping elect allies of the hospital field and the patients you serve is key to our advocacy strategy. That's why a strong IHA PAC, with its ability to amplify the stories and issues of hospitals, to open doors and foster relationships with lawmakers in Iowa and in Congress, is more crucial than ever.

With so much riding on our political involvement, we are asking for your leadership and participation. Your personal contribution and those of your colleagues in your hospital or health system will allow the IHA PAC to play an even bigger role in the 2024 elections.


The IHA PAC's campaign goal for 2023 is \$125,000 and the IHA PAC team has made the process easy for you to decide how best to participate by choosing one of two options:

- **DIY (Do It Yourself)** - the IHA PAC team lends you a hand where needed, or
- **DIFY (Do It For You)** - the IHA PAC team takes on much of the effort of advocacy by providing you with the materials you need, based on your approval.

Regardless of which option you choose, the IHA PAC team will work with your hospital's volunteer campaign coordinator to review a plan of action that will enable your success. Simply review our two-step plan of action to begin the process. If you have questions, contact the IHA PAC at ihapac@ihaonline.org.

We hope we can count on you to join us. As always, our visibility at the state capitol and in Washington, D.C. must be strong and our voice must remain loud. We must continue to be politically active and work to broaden our base of supporters. In these times of uncertainty, hospital leaders cannot afford to stand on the sidelines.

We thank you for your support and look forward to working with you and your colleagues.



To ensure that your IHA PAC campaign runs smoothly, please follow these simple steps below:

Step 1: Seek an individual to volunteer to work with us on your IHA PAC campaign.

To make this effort successful, seek a volunteer who will oversee the IHA PAC solicitation program and be the liaison with IHA. The volunteer should complete the IHA volunteer campaign coordinator form and return it to IHA PAC staff.

Step 2: Connect your IHA volunteer campaign coordinator with us.

Your volunteer campaign coordinator will receive a kit from the IHA PAC that contains sample solicitation materials that we have made available for your review.

In conjunction with your volunteer campaign coordinator, your IHA PAC campaign can begin. The IHA PAC team looks forward to working with you and/or your volunteer campaign coordinator on this important effort to support the IHA PAC.

Congratulations on accepting the role of a volunteer campaign coordinator.

Thank you for volunteering to work on your hospital's IHA PAC campaign.

IHA has created two models for success – DIY (Do It Yourself) or DIFY (Do It For You).

With the DIY model, the IHA PAC provides the templates for materials and guidance. Feel free to use the materials as you wish and customize them to your needs. All of the materials in this kit are available for download on the IHA website or by contacting IHA. How and when you execute the campaign must be done only on your voluntary time and without the use of hospital resources.

For the DIFY model, IHA staff will execute the campaign for you on a schedule of your choice.

Two Fundraising Campaign Options to Help the IHA PAC

Do It Yourself (DIY)



CEO or designee signs the prior approval form



Toolkit of materials sent to hospital PAC contact to customize.



Comply with Federal Election and IRS rules.



Work with IHA to recognize donors.



IHA staff support provided as you request.

Do It For You (DIFY)



CEO or designee signs the prior approval form



Work with IHA PAC staff to design your campaign based on IHA PAC prepared templates.



Materials are sent by IHA PAC staff to an approved list of hospital employees and on a schedule you request.



IHA staff follows up with donors as approved.



IHA PAC recognizes donors.

We have provided the steps for each model depending on your choice. If you decide to change gears and want to move to the other model at any point during the campaign, please let us know. Do It Yourself (DIY)

Step 1: Meet with IHA Staff

The IHA PAC will help launch your campaign by providing templates for your solicitations, supporting background materials and guidance. They can put you in touch with other successful volunteers.

Step 2: Identify Potential Contributors

Create a list of colleagues who could contribute keeping in mind those "eligible" under federal rule defined in these materials. Potential contributors including:

- All salaried, full-time employees holding supervisory and managerial positions.
- Trustees/board members.
- Physicians that are full-time, salaried employees of the hospital.

Hospital leadership is usually willing to do their part. The C-suite involvement in the campaign and support of the IHA PAC are critical to its success.

Under certain circumstances, human resources may be allowed to provide a list to you for solicitation purposes.

The list should include full contact information including name, title, employer, address, phone and email for prospective contributors. If your hospital is a 501(c)(3) organization, all contact information should be personal only (home phone, home address, personal email).

Step 3: Send Letters/Emails to Potential Eligible Contributors

Using the sample templates, please customize and send the solicitation materials to potential contributors. Please be sure to use the guidelines in this kit for sending and receiving purposes.

Every IHA PAC volunteer uses his or her personal resources to contact potential contributors. This means sending materials from a personal email address, using personal or IHA letterhead/stationery, paying for postage from personal funds, and using voluntary time to make the ask.

Potential contributors should not receive materials through work emails and work addresses. Personal emails and home addresses must be used.



Step 4: Follow-up

After sending the initial solicitation letter, following up with each potential contributor is recommended.

Be careful not to pressure staff. Giving to the IHA PAC is voluntary. Individual employees must be able to refuse to contribute without any reprisal.

Step 5: Sending Contributions

Individual donors should be directed to make checks payable to the IHA PAC and send check contributions to:

The IHA PAC does not accept cash.

Checks should be written at each donor's home and sent from home. Personal postage must be used, the hospital or organization postage may not be used. Checks may not be delivered from the employer or any other corporate organization's mailroom.

Step 6: Say Thank You!

Whatever the contribution, the volunteer campaign coordinator should send a thank you message. Remember, today's thank you is the beginning of next year's IHA PAC solicitation.

Handy Guide For Your PAC Solicitation Efforts

DIY Guidelines for Administering a PAC Fundraising Campaign

- Only individual contributions from U.S. citizens can be accepted. Contributions directly from a hospital account are prohibited.
- The campaign will run through Sept. 30.

Who can be solicited for IHA PAC contributions?

- All salaried, full-time executive, managerial or administrative hospital-employed staff.
- Trustees/board members.
- Physicians, who are employed directly by the hospital.

What are suggested contribution levels?

Title/Position	Small Facility	Large Facility
CEOs and Trustees	\$1,000	\$2,000
Senior Vice Presidents/ Vice Presidents	\$500	\$750
Directors	\$150	\$350
Managers	\$75	\$150

To ensure compliance with Federal Election Commission and IRS laws and regulations:

- Volunteer campaign coordinators and all individuals soliciting IHA PAC contributions should be acting in a personal capacity and are not acting on behalf of the hospital or health system.
- Written solicitations must be on personal stationery or IHA PAC letterhead. The use of hospital letterhead and other hospital resources is prohibited. IHA PAC staff can provide letterhead or an electronic image of the IHA PAC logo for your use.
- Any communications should clearly state that all IHA PAC contributions are voluntary and that any amount given or the decision not to give does not affect job status, performance review, compensation or employment.
- Solicitation of board members to contribute to IHA PAC or participate in a political event should not be part of the board meeting agenda. It should be discussed before or after a board meeting, or during an official break in the meeting.
- Neither hospital funds nor hospital resources may be used to underwrite fundraising mailings or activities.
- When conducting a solicitation, the person who sends an email or letter should do so through a personal account rather than using hospital resources. Likewise, the recipient should receive the materials through their personal emails or accounts.
- Meetings should be conducted on personal time for hospital employees involved in the campaign.
- Political contributions to IHA PAC are not tax-deductible and are not eligible for reimbursement from the organization.



IHA PAC Disclaimer

You must use or include the following IHA PAC disclaimer on all solicitation material:

Contributions or gifts to the IHA PAC are not deductible as charitable contributions for federal income tax purposes. Your contribution is important to us, but we want to emphasize that all contributions are voluntary and have no impact on your job status, performance review, compensation or employment. Any giving guideline is merely a suggestion. You are free to give more or less than the guidelines suggest, up to the permitted \$5,000 per year. Any amount given or the decision not to give will not advantage or disadvantage you. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in a calendar year (January-December). Contributions to the IHA PAC will be used for a political purpose.

Do It For You (DIFY)

Step 1: Meet with IHA Staff

The IHA PAC will launch your campaign for you after materials are approved, a timeline is agreed to and a list of potential contributors has been provided. We will talk about each step to assure your comfort with the campaign and keep you posted on our progress.

Step 2: Identify Potential Contributors

Create a list of colleagues who could contribute to the IHA PAC keeping in mind those “eligible” under federal rules defined in these materials. Potential contributors may include:

- All salaried, full-time employees holding supervisory and managerial positions;
- Trustees/board members; and
- Physicians, as long as they are full-time, salaried employees of the hospital.

Hospital leadership is usually willing to do their part. The C-suite involvement in the campaign and support of AHAPAC are critical to its success.

Under certain circumstances, human resources may be allowed to provide a list to you for solicitation purposes.

The list should include full contact information including name, title, employer, address, phone and email for prospective contributors. If your hospital is a 501(c)(3) organization, all contact information should be personal only (home phone, home address, personal email).

Step 3: Execution

The IHA PAC team will execute your campaign.

Step 4: Thanking Contributors

The IHA PAC team can send thank you notes or work with you to devise an appropriate way to thank contributors if you want to be part of the process.

Step 5: Evaluation

The IHA PAC team will schedule time to meet with you about the campaign and processes that worked or did not meet your needs. Our goal is to ensure everyone wants to be part of the IHA PAC's campaign success.

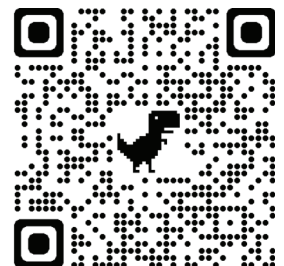

Fundraising Events and Cash Donations For Your PAC Solicitation Efforts

What are the guidelines for campaign fundraiser events?

If you sponsor an event, you should have a sign-up sheet that includes:

- Brief description of the type of fundraiser and date of the event.
- Total number of individuals donating \$10 or less and the sum of dollars received in this category.

The sign-up sheet(s) should include the following information from each participant who donates \$11 or more.

- First and last name.
- Home address.
- Individual cash donation amount.
- Date.

Cash Donations

When submitting cash donations, please DO NOT mail them to IHA. In lieu of sending cash, it is permissible to use a money order. Corporate checks are not allowed. Please DO NOT deposit cash in your hospital's account and then submit a check from your hospital's account. When mailing multiple contributions or an entire hospital campaign, please use a mail service with a tracking number.

Recognized Individual Leadership Contributions

AHA and IHA recognize the following personal leadership contributions:

- President's Circle: \$5,000+
- Champions Club: \$2,500+
- Ben Franklin Club: \$1,000+
- Chair's Circle: \$500+
- Capitol Club: \$350+

Most Valuable PAC Players and Grassroots Champion

Each year, the IHA PAC, in partnership with the AHA PAC, selects two Iowa hospital PAC campaigns that went above and beyond and an Iowa hospital leader who was committed to advocating on behalf of IHA issues with their legislators. These award recipients are forwarded to AHA and receive an award plaque as well as recognition at the AHA and IHA annual meetings.

IHA PAC Donor Clubs

The IHA PAC is appreciative of all contributions. Five club levels have been established to recognize members for their generous support.



President's Circle (\$5,000 per year)

The President's Club was established in 2021 as more hospital leaders and advocates step up their support of the IHA PAC. Contributors at the \$5,000 level will receive priority seating at AHAPAC events, invitations to participate in quarterly calls with political experts, access to insider political information about elections and recognition at AHA national meetings and IHA state meetings.



Champion's Club (\$2,500 per year)

Contributors at the \$2,500 level will receive priority seating at AHAPAC events, invitations to participate in quarterly calls with political experts, access to insider political information about elections, and recognition at AHA national meetings and IHA state meetings.



Ben Franklin Club (\$1,000 PER YEAR)

The \$1,000 level is named for the co-founder of the Pennsylvania Hospital, the nation's first hospital in 1751. Contributors at the \$1,000 level will receive invitations to participate in bi-annual calls with political experts, access to insider information, and recognition at AHA national meetings and IHA state meetings.



Chair's Circle (\$500 per year)

Established in 1997, the Chairman's Circle has grown each year and is now an essential support base of the PAC. Members receive access to insider information and recognition at AHA national meetings and IHA state meetings.



Capitol Club (\$350 per year)

Since 1978, the Capitol Club has been the backbone of the IHA PAC. Members will receive recognition at AHA national meetings and IHA state meetings.

Cash Donations and Campaign Fundraiser Events Sign-In Form

Some IHA member hospitals host fundraising events with a free will basket where individuals may contribute cash. When submitting cash donations, state law requires details for every contribution of \$11 or more be submitted by the hospital and be on file with the IHA PAC.

IHA members are welcome to use this form to collect the required information.

When submitting cash donations, please DO NOT mail them. In lieu of sending cash, it is permissible to use a money order. Corporate checks are not allowed. Please DO NOT deposit cash in your hospital's account and then submit a check from your hospital's account. 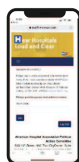

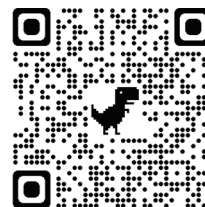
